JUNIOR FAIR LIVESTOCK INFORMATION

Reminder - Drug Use Notification Form (DUNF) ONLINE

It is time to get your DUNFs done! Continuing from last year, the State is requiring all Drug Use Notification Forms (DUNFs) be completed and submitted online. Paper forms will no longer be accepted. On Friday, August 25th, all Jr. Fair 4-H livestock exhibitors were emailed a DUNF survey to their family email address through the 4-H Online system. All club and FFA chapter advisors will also be emailed the link with instructions to share with their members, and it was posted on the Belmont County 4-H Facebook page. We ask that you complete it as soon as possible to give us time to review each one prior to weigh-ins. Exhibitors and their parent/guardian will be required to sign off on the form when submitting. A DUNF must be completed for every Jr. Fair market animal and lactating dairy cow and lactating dairy goat(regardless of current status of lactation), and egg production chicken prior to weigh-in and showing at the county fair. Animals will not be weighed without a completed DUNF submission. DUNF SUBMISSIONS ARE DUE SEPTEMBER 1ST.

GROOMING RULES: From page 58 of the Fair Tab under General Livestock Rules: All clipping, grooming, and shearing must be done prior to animal's arrival at the fairgrounds. No artificial color, adhesive, enhancers, etc. may be used in preparing market animals for the fair. Market animals should be washed and brushed only. NO sleeves, blankets, ice packs, ice, wet towels and drenching is permitted. If anyone is found guilty of this offense, he/she will be penalized by being ineligible to show (including showmanship) and sell that species of animal the present year and will be ineligible to bring any animal to the fair the following year. 4-H/FFA members preparing for Breeding Classes will not be restricted from grooming or clipping their animals. It is required that the member be present and actively participating in preparing project animal(s) they are going to show. For clarification, see specific rules that pertain to your species. (from page 56 of Belmont County Fair Tab under General Livestock Rules)

WEIGH-INS: All Jr. Fair market animals, excluding poultry and rabbits, must be in place by 4:00pm on Monday, September 4th. Weigh-in begins at 5:00pm, hogs will be in the hog barn and all other large animal species will be in the scale building behind the Junior Fair Board Office. Sheep and goats will go first, then steers and feeder calves. All other Jr. Fair animals must be in place by 7:00p.m., Tuesday, September 5th. Rabbit weigh-in begins at 7:30p.m, immediately followed by poultry weigh-in.

LIVESTOCK SALE RULES: Market exhibitors with an animal going through the livestock sale must let the Sale Committee know of their animals being sold by the conclusion of the beef show or 8:00pm Wednesday night. Animals will not go through the sale if it is not reported to the committee. Continuing from last year, there is a system for reporting "Will Sell" animals. Exhibitors must pick up their "Will Sell" card from the Jr. Fair office to complete, sign, and return it to the Junior Fair office by Wednesday night after the beef show. We will no longer accept a name written on a list at the office window. If you do not turn your "Will Sell" card back into the office, your animal will not be on the sale bill and will not be sold.

Cloverbud News

All Cloverbud fair exhibits will be displayed in a county-wide Cloverbud Booth in the Jr. Fair Booth Building. All Cloverbuds are to bring one craft item they made with their club to display in the county booth. Exhibits may be brought during booth decorating hours.

The Cloverbud advancement ceremony will take place during the Jr. Fair Awards Ceremony at the fair on September 4th, beginning at 1:00pm in the Robinson Stage Building. Invitations were mailed out to all Cloverbud members who will be aging up into traditional 4-H membership status at the completion of this program year.

Award and Trophy Winners

All trophy/award winners are required to write a thank you note to the sponsor of their award. Thank You notes are located in the Jr. Fair Board Office which is located behind the Livestock Show Arena on the Fairgrounds. These are available for all still projects and livestock project awards. Any trophies or t-shirts that are won by members can be picked up at the Jr. Fair Board Office after the awards ceremony and during fair week upon completion of the Thank You note. Livestock awards are awarded at the show, but are returned to the Jr. Fair display in the Livestock Show Arena. These awards will be released on Saturday at 8:30am, provided the thank you note has been completed. Congratulations to our winners!

4-H Teen Ambassador Applications

Wanting to get more involved in leadership opportunities with Ohio 4-H? Consider joining Teen Ambassadors! Any youth between the ages of 14-18 (as of January 1, 2024) is invited to become part of the Belmont County 4-H Teen Ambassadors group. Teens 13 to 19 years of age as of January 1, 2024 who are interested in serving on the 2024 Jr. Fair Board should complete a Jr. Fair Board application and return it to the OSU Extension Office by 4:30pm on October 1st, 2023. Applications will be available at the Junior Fair Board Office during the week of fair and will be available at the OSU Extension Office following fair. Jr. Fair Board terms will run from November 2023 through October 2024.


