

Skill-a-thon & Project Judging

Livestock Skill-a-thon

Livestock Skill-a-thon is for all 4-H and FFA members who are enrolled in a livestock project. These youth must participate in this event in order to show their livestock at the Belmont County Fair in September.

Skill-a-thon will take place:

Tuesday, August 9th, starting at 4:00pm at Union Local Middle School. There will be no early registration. Youth can arrive between 4:00-6:00pm. Judging will be on a first come first serve basis. Please arrive by 6:00 at the latest!

- 1. Skill Stations Refer to the study guide that is noted in the Belmont County Handbook or the packet that was sent home to you for what to study for each specific species and age area. (Junior/Senior)
- 2. Project Book Judging Complete all project areas to the best of your ability. An "N/A" is appropriate only in areas that absolutely do not apply to your project. The book judge will want to see you completed your book thoroughly. ALL projects require a <u>one-page</u> report that describes what you learned this year. Some record books have this page included as part of the project, but if yours does not, you need to write the report on a piece of paper and put it in the front of your book.
- 3. Interview Youth will be interviewed in conversation style by someone knowledgeable in their species area. Topics of discussion include general project knowledge, nutrition and feeding, management and health, selection and showing, and daily routine. Don't forget to dress appropriately, have a great smile, good eye contact, enthusiasm for your project and good manners. These will surely make a great impression on the judge!

Skill-A-Thon Make-Up and Still Project Make-Up will take place:

Tuesday, August 16th at the Extension Office.

- You must call the Extension office prior to that date and let us know you will be attending make up judging.
- 2. Judging will take place from 9:00am-4:00pm on a first come first served basis.
- 3. Those attending make up judging will not be eligible for county awards.



Junior Fair Livestock Entry Form Procedure

Junior Fair Livestock Entry Forms for **ALL** livestock projects will be available beginning August 9th at Skill-a-thon through Make Up judging August 16th. The entry forms must be completed, signed by vouth and parent/guardian, and turned in the day of your Skill-A-Thon judging or by August 16th to the **Extension office. Come** prepared with any identifying tag information you will need to include on the form (Ex: birthdate, ear tag, **SCRAPIE** tag, etc.) **Livestock Entry forms** are required to exhibit live animals at the fair.

Reminder: Spot checks conducted by Senior Fair board can occur at any time between now and fair.

Please make sure your animals are tagged and housed at their registered address.

Junior Fair Livestock Information

NEW Drug Use Notification Form Procedure:

Starting this year, the State is requiring all Drug Use Notification Forms (DUNFs) be completed and submitted online. Paper forms will no longer be accepted. All Junior Fair 4-H livestock exhibitors will be emailed a DUNF survey to their family email address through the 4-H Online system on Monday, August 29th. County Junior Fair FFA members will be sent the link from their FFA advisor. All youth will have through Friday, September 2nd to submit their DUNF(s). Exhibitors and their parent/guardian will be required to sign off on the form when submitting. The 4-H office will run a report on September 3rd to see who has not completed their form. We will also receive an email from the State if there are any issues with forms submitted. If anyone does not have the ability to complete an online form, you are welcome to do so at the Extension office during that week prior to the fair. Please call us to schedule a time.

A DUNF must be completed for every Junior Fair market animal and lactating dairy cow and lactating dairy goat prior to weigh in and showing at the county fair. Animals will not be weighed without a completed DUNF submission.

Contacting Your Livestock Buyers

Now is the time to be talking to potential buyers for your market project. The Livestock Sale Committee is provided with a limited number of tickets to park on the grounds, Thursday only, to give to these buyers. Any new buyer you would like to have included is welcome. Contact Beth Stephens (740) 391-0021 with the names and addresses of any new buyers. It is the responsibility of each individual youth to invite potential buyers either by letter, in person, or both. Items to include in the letter or discussion: Name, age, 4-H club, school attending, grade, and identify the market project you are selling (breed, sex, and tag number). It might be helpful to include a picture of yourself and the market animal being sold. Be sure to include to Livestock Sale Schedule for 2022 from the fair tab to ensure your buyers are there for your sale time.
